The International Committee of the Red Cross (ICRC) is an independent and neutral organization whose mandate is to protect and assist victims of armed conflict and promote International Humanitarian Law (IHL). The respect of the medical mission during armed conflict is a core part of IHL.

In order to share ICRC experience and knowledge and to assist health care professionals in conflict-affected areas of Basilan, Sulu and Tawi-tawi to prevent the disruption of health care provision by incidents related to the dynamic of the conflict, ICRC would like to propose a workshop:

**“Health Care in Danger:  
preventing disruption of health care by conflict in Basilan, Sulu and Tawi-tawi  
(BaSulTa)”,  
in Zamboanga City on 21 and 22 March 2018.**

The objectives of the workshop would be:

- to raise awareness about the principles of respect of the medical mission and the ICRC experience in prevention of incidents,
- to discuss the challenges faced by health staff in BaSulTa due to the conflict, and
- to identify specific measures that can be taken in BaSulTa to prevent incidents or mitigate the consequences.

ICRC will cover transportation, accommodation, and food costs during the workshop which will take place at the Ever O` Hotel in Zamboanga City. Participants are expected to arrive at 8:30 am on 21 March 2018.

We are confident that you will facilitate the realization of this workshop on *Health Care in Danger (HCiD)*, within a spirit of partnership between ICRC and ARMM DoH, which will benefit the provision of health care in Basilan, Sulu and Tawi-tawi
