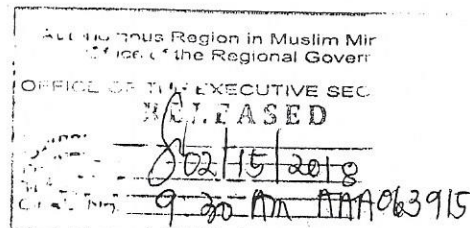

Dear Gov. Hataman,

WFP will begin a new 5-year Country Strategic Plan (CSP) beginning this July 2018. The Plan has four strategic outcomes: Emergency Response, Ending Malnutrition, support to Food Security and Nutrition in ARMM and Capacity Strengthening and Development.

The Framework of Agreement between ARMM Government and WFP signed last 13 March 2017, in line to the objective of the CSP requires WFP to provide assistance in the area of capacity development. Through which, we were able to assist ARMM-HEART conduct the Comprehensive Food Security and Vulnerability Assessment in 20017 for the whole region. Another area of support is in the Formulation of the Regional Plan of Action for Nutrition (RPAN).

Highlighted in your speech last January 21, 2018, during the ARMM Philippine Plan of Action for Nutrition Dissemination Forum, was the very high prevalence and magnitude of malnutrition and its multiple causes that hinder achievement of peace and development. Your challenge on how to prioritize and support ARMM to address this lingering problem was proactively responded to by partners together with the regional health and nutrition officials by planning to have a good strategy.

This coming February 26-March 2, 2018, the National Planning Team commissioned by the National Nutrition Council will conduct an RPAN Formulation workshop for ARMM back to back with Region 12 in Davao City. In this connection, we are requesting your office to allow the members of the Regional Nutrition Council, especially the Head of Agencies and Planning Officers and DOH personnel to attend this activity. Attached is the list of participants. Due to the limited time of the planning team and the need to also do the same activity to other regions within the first quarter of this year, Davao City is the most strategic and center point for the workshop.

Meals and accommodation of the participants will be funded by WFP, while travel allowance, per diem and incidental expenses will be covered by the sending agency.
