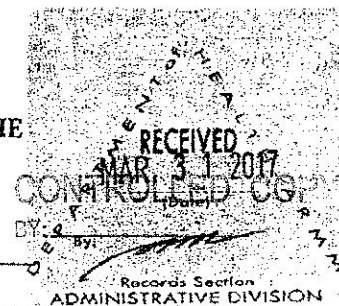

3. Offices and departments that are tasked to monitor the criteria and conditions for the grant are instructed to give update on the status of the agencies' compliance on these requirements to ensure ARMM's eligibility for PBB.
