Pursuant to Executive Order No. 08, the Bangsamoro Transition Committee (BTC) is mandated to draft the Bangsamoro Basic Law for submission to the Office of the President and the Congress. **Series of En Banc Plenary Consultations** with stakeholders are currently being conducted to better address necessary concerns of those affected by its provisions.

In line with this, all Secretaries/heads of agencies, Assistant Secretaries, Human Resource Officers, ARMM Employees' Associations/Organizations, and experienced employees on previous transitions (Lupong Tagapagpaganap ng Pook (LTP), RA 6734, and RA 9054), are hereby enjoined to:


- 1) **Submit** insights, comments, and recommendations on the pertinent provisions of House Bill 4994 directly affecting your respective agencies on or before Wednesday, 17 May 2017. Kindly submit your position papers to the *Office of the Executive Secretary* and copy furnish the *Office of the Chief of Staff*; and
- 2) **Attend a Consultation Dialogue** on Thursday, 18 May 2017 at 1:00 PM- 5:00PM at Ibrahim Hall, Em Manor Complex, Cotabato City.

Any other groups or individuals who wish to comment or issue their position paper on the pertinent provisions of HB 4994 are requested to register to the Secretariat before the start of the session.
